Mission & Purpose

Position

The Board will support the work of the Citizens Coal Council and provide mission-based leadership and strategic governance. While day-to-day operations are led by CCC's Executive Director, the Board-ED relationship is a partnership, and the appropriate involvement of the Board is both critical and expected. Specific Board Member responsibilities include:

Leadership, governance and oversight

- Serving as a trusted advisor to the ED as s/he develops and implements CCC's strategic plan
- Approving CCC's annual budget, audit reports, and material business decisions; being informed of, and meeting all, legal and fiduciary responsibilities
- Contributing to an annual performance evaluation of the ED
- Assisting the ED and board chair in identifying and recruiting other Board Members
- Partnering with ED and board members to ensure that board resolutions are carried out
- Serving on committees or task forces and taking on special assignments
- Representing CCC to stakeholders; acting as an ambassador for the organization
- Ensuring CCC's commitment to a diverse board and staff that reflects the communities CCC serves

Fundraising

CCC Board Members will consider CCC a philanthropic priority and make annual gifts that reflect that priority. So that CCC can credibly solicit contributions from foundations, organizations, and individuals,

CCC expects to have 100% of Board members make an annual contribution that is commensurate with their capacity.

Board terms/participation

CCC Board members will serve a three-year term to be eligible for re-appointment of one additional term. Board meetings will be held quarterly, three meetings by teleconference and one in-person meeting. Committee meetings will be held in coordination with full board meetings.

Qualifications

This is an extraordinary opportunity for an individual who is passionate about CCC's mission and who has a track record of board leadership. Selected Board Members will have achieved leadership stature in business, government, philanthropy, and the nonprofit sector.

Ideal candidates will have the following qualifications:

- Extensive professional experience with significant leadership accomplishments
- A commitment to and understanding of CCC's constituents, preferably based on experience
- Savvy diplomatic skills and natural affinity for cultivating relationships and persuading, convening, facilitating, and building consensus among diverse individuals
- Personal qualities of integrity, credibility, and a passion for improving the lives of citizens living in coal impacted communities.
- Candidates with the following professional experience are strongly encouraged to apply: accounting, nonprofit management, public policy, and marketing.

Service of the CCC Board of Directors is without renumeration, except for administrative support, travel, and accommodation costs in relation to Board Member's duties.
